DRIVING DIRECTIONS

From Klamath Falls:

Take Hwy 39 south (turns into 139 in California) going past Tulelake approximately 3 miles. Turn left on Co Rd 101. Follow 101 to the end. Turn right on Co Rd 114. Go 2 miles and the field will be on the right.

From Redding:

Take I5 north. At Weed, take Hwy 97. Just past the town of Dorris, turn right on Stateline Road (Hwy 161). Follow it until the first stop sign (appx 20 miles). Turn right at stop sign on Hwy 139. Go appx. 7 miles. Turn left on Co Rd 101. Follow 101 to the end. Turn right on Co Rd 114. Go 2 miles and the field will be on the right.
